Rules: Two referees will be provided for each game. Each team will need to provide one adult scorekeeper or pre-pay \$20 scorekeeper fee per game. Teams not providing a scorekeeper will forfeit that game.

Games will consist of two twenty minute running halves.
The clock will stop for the final two minutes of the second half.

Teams will be granted three time outs per game.
Half time will consist of four minutes. In all divisions,
a full court press will only be permitted during the second
half and only if the score differential is less than 20 points.

Players are allowed five personal fouls. Bonus free throws will be awarded based on Federation Rules.

Substitutions are permitted on dead ball situations only.

All teams must have uniform shirts with visible numbers on the back.

POSITIVE sportsmanship is a requirement of coaches, players and spectators. Technical fouls awarded exceeding two per participant: coach or player associated with unsportsmanlike conduct will result in immediate expulsion from tournament play for the remainder of the tournament. Spectators displaying unsportsmanlike conduct will also be ejected from the facility.
